

DEAR MEMBERS OF THE FRIENDS

On behalf of the Executive Committee, I have the pleasure of presenting the 69th Annual Report of the Association of The Friends of King's College for 2023.

2023 was the first year since the Covid Pandemic, where the Friends of King's College were able to run a full schedule of events uninterrupted by covid restrictions. The events held were extremely successful, due to the great support we received from you – whether volunteering your time to arrange events, coming along and enjoying them or contributing to the fundraising opportunities.

Your support delivered excellent results. The Friends Committee were pleased to donate the sum of \$564,458 back into the College community in 2023, including a large contribution to the High-Performance Gym Project which allows for a new girls changing room facility and returns the Friends Gym to a full Basketball Court.

At the 2023 AGM we bid farewell to resigning member Harinder Kaur, Sara Guo, Ashley Renshaw and Sara Mead and we thanked them for their time and efforts on behalf of the Friends. We also gave our special thanks to David Moore for four years of tireless service as president of the Friends.

Anne Wight was elected as the incoming president of the Friends along with vice president Nicky Hall and continuing vice president Hayley Whatuira. We also welcomed new committee members, Mel Hargrave, Christina Bai, Angela Wong and David Martin, and thanked all our volunteers.

FRIEND-RAISING AND FUNDRAISING ACTIVITIES IN 2023

HEADMASTERS GARDEN PARTY

The Headmasters Garden Party is a Friend-raising event, we had a great turnout of over 150 parents and caregivers. The idea of the Headmaster's Garden Party is to welcome new and existing parents and families back to the College for the new year. Despite the rain, it was a successful event, and a fantastic opportunity to encourage new and existing parents to become involved as volunteers for the Friends of King's College.

GIBBS FARM


This was a great event where over 150 family and friends of the King's College Community took the opportunity to enjoy the spectacular Gibbs Farm open-air sculpture park located in the Kaipara Harbour. It was a successful event enabling people to exclusively enjoy the largest collection of largescale outdoor sculptures in New Zealand. This event was run by David Moore and returned a net surplus of \$16,519.

GOLF DAY 2023

This event was held at Remuera Golf Club with 28 teams playing. It was a brisk winter day with the teams competing for the various prizes and honours available. There was an enthusiastic and capable group of volunteers who pulled together some fantastic auction prizes and raffles for the event. We thank all the businesses and individuals that supported this event and donated items to be part of the auctions and raffles. This event was run by David Moore and Paul Sissons and returned a net surplus of \$44,895.

LADIES LUNCH

This is an event that ladies book out way in advance and sells out quickly. This year's Ladies Lunch was held in the beautiful surroundings of the Northern Club. The event was started with a Karakia from new King's College





board member Stacey Morrison. 110 participants enjoyed a delicious lunch while listening to committee member Helene Bizouerne-Grayson introduce guest speaker, Silvana Schenone, who is the Managing Director and Co-Head of Investment Banking at leading investment bank Jarden and an active board member including the New Zealand Takeovers Panel. Silvana gave an interesting and inspiring presentation that was enjoyed by all the attendees. We acknowledge our gold sponsor Orsini Fine Jewellery and thank Sarah Hutchings for her continuing support for this event. We also thank a Touch of Spice for supplying us with a fantastic auction item for the event. The event was run by Helene Bizouerne-Grayson, Cecelia Lambie and Anne Wight with a focus on friend- raising and returned a net surplus of \$1,250.

ART EXHIBITION

The 2023 Art Exhibition was held over the weekend of the 27–29th of October2023. A committee of over 50 members led by Pru Mandeno, and Julie Mathias, put together this event. We would like to thank every one of these volunteers, for their assistance with the event.

This year, the Art Exhibition Committee decided to focus on a slightly smaller collection of artworks without compromising on quality. The art selection team did a wonderful job of balancing the different genres, price points and tastes in art. There certainly seemed to be something for everyone and the standard of the artwork exhibited was incredibly high.

A new way to purchase the art was also developed using QR codes, which was a great success and made things easier for the customer and opened up sales to online purchases. This innovation received excellent feedback from all attendees.

During the weekend, an Art Box exhibition was also added to the event. This displayed smaller items that were available to be taken home on purchase.

We would like to thank our generous sponsor – The Foundation Parnell, who were a perfect fit for this event.

Thanks to the Arts Exhibition leaders, committee members and helpers for their generous contribution of time, energy and passion over the many months of planning and organisation, culminating in an amazing weekend of art. This event returned a net surplus of \$62,849.



PRE-LOVED UNIFORM SALES

There were two pre-loved uniform sales held in 2023. Both were very busy on the day and received great support from the King's community.

Mary Jones and Hayley Whatuira, supported by David Moore and Christina Bai, worked tirelessly over the year to support this initiative and I thank them both for their hard work and dedication.

If anyone has any outgrown school uniform, please let us know, as we need to build our stocks back up again!

These events returned a net surplus of \$29,704.

THE VOLUNTEERS PROGRAMME

Over and above events that the Friends organise, there are other activities that are also supported by Friend's volunteers which are hugely valuable to the College. We thank all those that give their time to support the Tuck Shop, the Library and the Exam Reader/Writer programme and the many other areas where Friends' volunteers help around the College.

DONATIONS AND FUNDING IN 2023

In 2023 the Friend's raised (incl. donations) a total of \$273,117. The Friends Committee receives funding requests throughout year. These are reviewed with the College and the Committee and if in agreement, the Friends Committee then allocates the monies requested. The donations benefit all areas of the College community, including to support the Houses, the Arts and Music Programmes and larger community projects such as the resurfacing of the Greenbank sports surfaces and the cricket nets.

In 2023, the Friends supported school projects for \$64,458. In addition, the Friends contributed of \$500,000 to High Performance Gym Project which allows for a new Girls' changing room facility and returns the Friends Gym to a full Basketball Court.
